All vote-by-mail ballot requests have expired, voters need to update request. Due to the passage of Senate Bill 90 in 2021, which revised certain sections of the state's election laws, voters now have to renew their request for a mail-in ballot after every General Election cycle for future elections.

That means Vote-By-Mail requests submitted before the November 8, 2022, General Election expired on December 31st, 2022. This affects a lot of people. If you want to renew that request, now's the time to do it.

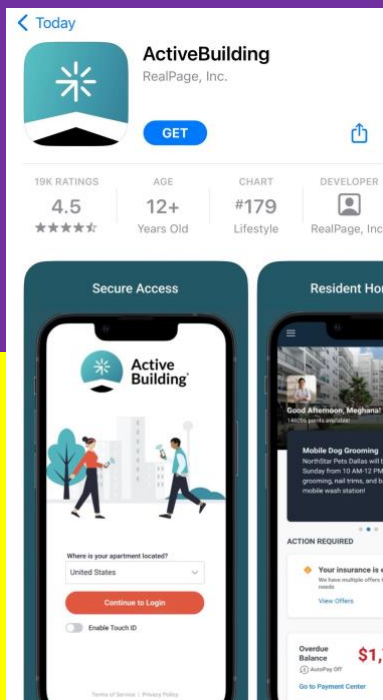

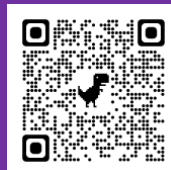
